Many genuine and durable partnerships were cerebrated, confirmed or renewed at the recent United Nations Small Island Developing States (SIDS) conference, held last month in Samoa.

SIDS closed on a very high note and our visitors to the shores of Samoa were impressed with almost everything! The venue, the culture, the hospitality, the food and the weather. Keeping the momentum of SIDS moving forward depends on you and me as SIDS was very much about us all as small island developing states.

SPREP is keeping the momentum of SIDS alive, kicking off with a regional workshop held last week at the Secretariat campus where the Kyoto Protocol Adaptation Fund (AF) was involved to clarify approved processes for developing and submitting projects to be funded by the AF. Participants from around the region were taken through the whole cycle of Adaptation Fund project development. A staff of the Green Climate Fund (GCF) responsible for the Asia-Pacific Region also presented on the status of the GCF and on up and coming opportunities for the region through their Readiness Programme. It is envisaged that the fund will be operational in November 2014.

UNEP Climate Technology Centre and Network (CTCN), in partnership with SPREP, ran a day and a half workshop on how they could support PICs through technical assistance related to both adaptation and mitigation technology transfer and development.

In the true spirit of partnership, last week's work was also supported by generous contributions by the Asia Pacific Adaptation Network (APAN); Secretariat of the Pacific Community through the European Union funded Global Climate Change Alliance (GCCA) Small Island States project; and the Pacific Islands Forum Secre-
