

Figure 4 Management of Funds in the GoN Budget



Figure 5: Changes in the proportion of total expenditure that is climate relevant over time




Figure 3: Highest climate relevant spending agencies as proportion of total 'climate budget' 4

CPEIR Key Recommendations (2.1)



- Climate change is an environment concern as well as a social and economic concern
- Planning and Finance have a key role in facilitating the incorporation of CC concerns into policy development and public investment planning
- Need for prioritization and financing plan
- Build upon existing government reform programmes

CPEIR Key Recommendations (2.2)



- Annual Monitoring Report
- Finding efficiencies with overlap of CCA and DRM institutional structures
- Capacity development for policy appraisal, monitoring and evaluation (functional capacities)
- More awareness of climate change at the local level

CPEIR Key Recommendations (2.3)



- Parliamentary committees have a potential role for oversight.
- Build upon existing planning and allocation systems
- Incorporate a functional marker to track expenditure
- Introduce indicators to measure quality of climate relevant expenditure

CPEIR Key Recommendations (2.4)



- Go beyond climate change relevance of all expenditures to climate change but the policy objective
- Look at the overall composition of public expenditure including taxation
- Focus on "dirty" expenditure


